- ☑ Living Lab/Workshop with representatives of the main stakeholders applying the FAO Progressive Management Pathway for AMR (PMP-AMR) to the evaluation of the poultry sector to identify potential improvements
- ☑ Living Lab/Workshop with the main stakeholders to identify potential improvements in the Guidelines for prudent AMU in the pig sector

# **KEY RESULTS**



- ☑ Increased awareness of operators and the public through training and education for the poultry sector
- ☑ Provision of specific national funds for AMR research in poultry farming
- ☑ Investigation on the potential spreading of AMR through the environment in poultry farming
- ✓ Harmonize the use of antibiotic risk categories (WHO, EMA) used in Europe; keep record of microbial sensibility to antibiotics at the farm level; reduce the time needed to communicate lab-test results; increase training on AMR and prudent AMU; clarify criteria for animal group treatments; improve the monitoring of lesions at slaughtering in the pig sector
- ✓ Integrate farmers training on animal welfare with AMR and prudent AMU topics; incentivize precision livestock farming; promote farmer networking on such issues; apply direct payment to good animal health practices; set appropriate indicators for animal welfare and biosecurity measures in the pig sector

### **INDUSTRY**

☑ Increased involvement of all stakeholders for a responsible AMU in the pig and poultry sectors; improved transparency and better image of the poultry industry regarding animal welfare and AMR issues



### **FARMERS & TECHNICIANS**

Opportunity to share experiences with other private and institutional stakeholders; co-evaluation of the level of implemented good practices in the poultry sector according to global parameters

☑ Stimulus for an evolution of the animal health professions towards a One Health approach optimizing AMU by enhancing interconnections between human, animal, and environmental health; improved collaboration between public and private animal health operators




### POLICYMAKERS, CONSUMERS, CITIZENS
